RULES OF PROCEDURE FOR THE IMPLEMENTATION
COMMISSION

1. **Short title and commencement.**—(1) These rules may be called the Rules of Procedure for the Implementation Commission.

(2) These rules shall come into force at once.

2. **Definitions.**—(1) In these rules, unless there is anything repugnant in the subject or context:—

“**Chairman**” means the Chairman of the Commission;

“**Commission**” means the Implementation Commission constituted under Clause 9 of Article 270 AA of the Constitution;

“**Committee**” means a Committee constituted by the Commission for such purpose (s) as it may deem fit;

“**Constitution**” means the Constitution of the Islamic Republic of Pakistan;

“**Deputy Chairman**” means the Deputy Chairman of the Commission;

“**Experts and other persons**” mean the persons co-opted as such by the Commission for specified purpose and duration;

“**Gazette**” means the Gazette of Pakistan; “**Government**” means the Government of Pakistan;
