**NOTIFICATION**

No.1(1)/2010-CCI. In exercise of the powers conferred by clause 5 of Article 154 of the Constitution of the Islamic Republic of Pakistan, the Council of Common Interests (CCI) in its 44<sup>th</sup> meeting held on 7<sup>th</sup> April, 2021 is pleased to make the following amendments in the Rules of Procedure of the CCI, 2010:-

In rule 3, the existing sub-rule (1) along with the proviso shall be substituted with the following:

**“3. Secretariat of the Council.- (1) There shall be a permanent Secretariat of the Council. The Chairman/Prime Minister shall appoint Secretary of the Council from amongst the serving BS-22 Civil Servants of the Federation.”**


In rule-3, the following sub-rules (4) and (5) shall be inserted:

**“(4) The Secretary shall also be the Principal Accounting Officer of the Secretariat of the Council.”**

**“(5) The Secretary shall directly report to the Chairman of the Council/Prime Minister.”**

2. The Rules of Procedure of the CCI, 2010, notified vide S.R.O.741(I)/2010 dated 19<sup>th</sup> July, 2010 stands modified to the above extent.

3. This issues with the approval of the Secretary, Inter-Provincial Coordination Division/CCI.


