MANNER OF SUBMISSION OF CASES TO THE COUNCIL OF COMMON INTERESTS (CCI)

In accordance with Article 154(1) of the Constitution of Islamic Republic of Pakistan, the Council of Common Interests (CCI) is responsible for formulation and regulation of policies in relation to matters enumerated in <u>Federal Legislative List (FLL) Part-II</u> and to exercise supervision and control over related institutions. The manner of submission of cases to the CCI & preparation of summaries has been provided in Schedules II and III of Rules of Procedure of CCI, 2010 (available at www.ipc.gov.pk).

- 2. It has been observed that despite clear provisions of Rules of Procedure of CCI, generally the summaries submitted by Ministries/Divisions and Provincial Governments either do not fall in the purview of CCI i.e. FLL, Part-II or without incorporating views / comments of stakeholders / provincial governments. In several cases, the Summaries are received a few days before the date of the meeting has been fixed which do not provide sufficient time to the Honourable Members of the Council to study the proposals.
- 3. For placing Summaries before the CCI in complete form and proper appreciation of the cases, the following general guidelines are hereby repeated for information and compliance of all concerned:
 - i. Before submission of a case to Ministry of IPC (CCI Secretariat) it must be ascertained in the first instance whether the proposal contained in the respective Summary falls within the purview of CCI. In case of uncertainty, advice of Ministry of Law and Justice may be obtained before submitting a Summary.

ii. Prior consultation with all concerned stakeholders must be carried out and their views should invariably be incorporated in the Summary.

iii. In accordance with Rule 5 (8) of CCI Rules, for inclusion in the agenda of a meeting the summary relating to the case shall reach the Secretary, Ministry of IPC (CCI Secretariat) at least fifteen days in advance of the meeting.
