(3). **This shall enable the controlling Ministries/Division/ Authorities to ensure follow-up and prompt retrieval of PERs from the Reporting/Countersigning Officers.**

3. Reporting and Countersigning Officers concerned may be requested to kindly initiate/countersign the PERs as the following timeframe given in para 2.37 of AGPE-2004, has already lapsed.


