NOTIFICATION

- S.R.O. (I)/2020 In exercise of the powers conferred by section 5 of the Sports (Development and Control) Ordinance, 1962 (XVI of 1962), the Board of Pakistan Sports Board is pleased to make the following rules, namely:-
- 1. Short title and commencement.- (1) These rules shall be called the Director General, Pakistan Sports Board (Appointment) Rules, 2020.
 - (2) They shall come into force at once.
- 2. Method of appointment.- (1) The post of Director General, PSB will be of Management Position Scale II (MP-II).
- (2) Appointment to the post of Director General (MP-II), shall be made by Initial recruitment on contract basis through open advertisement in the newspapers, on merit.
- (3) The period of appointment to the post of Director General (MP-II) on contract basis shall be three years extendable for a maximum period of two years on annual basis subject to satisfactory performance.
- (4) Appointment to the post of Director General (MP-II) shall be made by the Prime Minister on the recommendations of the Selection Board constituted in rule (4) below. Annual extension in contract will also be given by Prime Minister on recommendations of Performance Evaluation Committee.
- 3. Conditions for appointment. (1) No person shall be eligible for contract appointment to the post of Director General (MP-II), if he,-
 - (a) is not a citizen of Pakistan or ceases to be a citizen of Pakistan;
 - (b) has been convicted for any offence under The National Accountability Bureau Ordinance, 1999 (XVIII of 1999) or an offence involving moral turpitude and sentenced for such an offence with imprisonment of either description for a term exceeding two years;
 - (c) has been dismissed, on account of misconduct from the service of any Government, Statutory Corporation, Organization, Authority or a Board established or controlled by or under the authority of a federal or provincial government, or in which any such government has controlling share or interest;
 - (d) has been adjudged as insolvent by a competent court of law; and

- (e) is incapable of discharging his functions for reasons of physical or mental incapacity; and
- (f) not within the age-limit specified in column (3) of that table, namely:-

4. Selection Board.- (1) The composition of Selection Board for making recommendations for appointment to the post of Director General (MP-II) shall be as under:-

- (2) The Chairperson of the Board may co-opt any member from the following on case to case basis:-
 - The non-executive Chairman of the Board of Directors or a senior member of the Board of Directors of the institution in cases where such Board exist.
 - ii) Expert having domain knowledge to be nominated by the Minister Incharge on recommendations of the Secretary concerned.
- (3) The Selection Board after conducting the interviews, shall recommend to the appointing authority a panel of minimum three (03) suitable candidates, in order of merit, for appointment against the post of Director General (MP-II).
- **5.** All other terms & Conditions and miscellaneous matters contained in Management Position Scales Policy, 2020 issued vide Establishment Division's O.M. No. 1/3/2020-E-6, dated 22nd June, 2020 and any further revision/amendment made therein from time to time, will also apply.
- 6. Repeal.- Those provisions of Pakistan Sports Board Service Rules, 2000 and such other instruments which relate in their application to the matters covered under these rules are hereby repealed.
