#### INTRODUCTION

Ministry of Inter Provincial Coordination was created initially on 24-12-1971, when it was headed by the Prime Minister himself. With intermittent interruptions, the Prime Minister of Pakistan approved the creation of a full Inter Provincial Coordination Division in the Cabinet Secretariat w.e.f. 19<sup>th</sup> March, 2007. The IPC related functions of the Cabinet Division were transferred to the Inter Provincial Coordination Division at the time of its creation. Subsequently, it was made a full fledge Ministry w.e.f. 3rd November, 2008. Due to 18<sup>th</sup> Amendment, the responsibilities of the Ministry of IPC have increased. Necessary amendments have been made in the Rules of Business, 1973 accordingly.

#### **VISION**

Pakistan, being a democratic Federation, enjoys full confidence of its Federating units. In line with the Constitution of the Islamic Republic of Pakistan, 1973, each Province should play its role in nation building without fear of discrimination by any other Province. All Federating units contribute towards formulation of national policies and resolution of issues being confronted in the social, political, economic and administrative fields. Inter governmental for through their deliberations serve the purpose of creating effective provincial harmony as well as unity between the federation & the Provinces, promoting and developing uniform standards of sports competitions in Pakistan comparable to the standards prevailing internationally and regulating/controlling through Pakistan Sports Board; and arranging bilateral cultural exchange scholarship programmes for Pakistani students in other countries.


#### **MISSION**

#### 2: COUNCIL OF COMMON INTEREST WING

The CCI Wing of IPC Division has been providing secretarial support to the Council of Common Interests (CCI) since March, 2010 when the Prime Minister of Pakistan approved the transfer of all secretarial work of the CCI from Cabinet Division to IPC Division. The wing is headed by the Additional Secretary (IPC) and is assisted by the Joint Secretary (CCI), Deputy Secretary (CCI) and two Section Officers i.e. Section Officers (CCI) and (Progress).

- 2. The Council of Common Interests (CCI) was incepted under the provisions of the Constitution of Islamic Republic of Pakistan, 1973. The passage of 18th Constitutional Amendment has further strengthened its purview through the expanded role of CCI whereby important subjects relating to Federation have been added in the Federal Legislative List, Part-II, for consideration of and decision by the CCI. The forum is headed by Prime Minister of Islamic Republic of Pakistan. It is an icon of federalism in the Country and provides the Federating Units (Provinces) an equal opportunity in the affairs of the federation.
- 3. In terms of Article 153(1) read with Article 154(2), the President of Islamic Republic of Pakistan appoints the Council on the advice of the Prime Minister of Pakistan within 30 days of taking the oath of Prime Minister. The CCI is responsible to both the houses of Parliament i.e. Senate and National Assembly. Its reports are annually laid before both the houses under Article 153(4).
- 4. The CCI was last re-constituted vide Notification No.1(2)/2010-CCI dated  $31^{\rm st}$  August, 2018, as under:-

The Secretary IPC Division is the Secretary of the CCI.

#### 2.1: FUNCTIONS OF THE COUNCIL OF COMMON INTERESTS

- 5. In accordance with Article 154, the Council is responsible to formulate and regulate policies in relation to the matters enumerated in Part-II of Federal Legislative List (FLL) and to exercise supervision and control over related institutions (Annex-I). The decisions of the CCI are appealable only in the Joint Session of the Parliament.
- 6. Article 155 of the Constitution also extends the purview of CCI to the resolution of a dispute amongst federation and the federating units or area's governments regarding their rights on water from any natural source or reservoir and authorizes the Federal or the Provincial Government concerned to make a complaint to CCI. The CCI can either decide or recommend the President to set up a Commission consisting of persons having knowledge and experience in irrigation, engineering, administration, finance and law under the Pakistan Commissions of Inquiry Act, 1956.
- 7. As regards "Electricity", the Article 157 while authorizing Federal Government to construct a hydro-electric or thermal power installation in any province in consultation with that province, also authorizes the Provincial Governments to draw bulk supply from National Grid for transmission and distribute within the province; levy taxes on consumption; construct power houses and grid stations; lay transmission lines and also to determine electricity tariff within the Province. In case of any dispute in the matter, the Federal or Provincial Government can approach the CCI for resolution of the dispute.


#### 2.2: **MEETINGS OF THE COUNCIL:**

# PURVIEW OF THE CCI (FEDERAL LEGISLATIVE LIST PART-II)


- 1. Railways;
- 2. Mineral oil and natural gas, liquids and substances declared by Federal law to be dangerously inflammable;
- 3. Development of industries, where development under Federal control is declared by Federal law to be expedient in the public interest; institutions, establishments, bodies and corporations administered or managed by the Federal Government immediately before the commencing day, including Water and Power Development Authority and Pakistan Industrial Development Corporation and all undertakings, projects and schemes of such institutions, establishments, bodies and corporations; industries, projects and undertakings owned wholly or partially by the Federation or by a corporation set up by the Federation;
- 4. Electricity;
- 5. Major ports, that is to say, the declaration and delimitation of such ports, and the constitution and powers of port authorities therein;
- 6. All regulatory authorities established under a Federal law;
- 7. National planning and national economic coordination including planning and coordination of scientific and technological research;
- 8. Supervision and management of public debt;
- 9. Census;
- 10. Extension of the powers and jurisdiction of members of a police force belonging to any Province to any area in another Province, but not so as to enable the police of one Province to exercise powers and jurisdiction in another Province without the consent of the Government of that Province; extension of the powers and jurisdiction of members of a police force belonging to any Province to railway areas outside that Province;

Council of Common Interests (CCI) is responsible to both the houses of Parliament i.e. Senate

and national Assembly. Its report is annually laid before these houses under the Article 153(4).

The CCI can either decide or recommend the president to set up a Commission consisting a person knowledge having and experience in irrigation, engineering, administration, finance and law under the Pakistan Commission of Inquiry Act, 1956.
- 7. As regards "Electricity", Article 157 while authorizing Federal Government to construct hydro-electric or thermal power installations in any province in consultation with that province also authorizes the

provincial government to draw bulk supply from national grid for transmission and distribution within province, levy tax on consumption, construct power houses and grid stations and lay transmission and also to determine the electricity tariff within the Province. In case of any dispute between the Federal Government and a Provincial Government in respect of any matter under this Article, any of the said Governments may move the Council of Common Interests for resolution of the dispute.

# MONITORING OF THE PROGRESS OF THE DECISION OF THE MEETING OF CCI

9. The progress of the decisions of 39<sup>th</sup> and 40<sup>th</sup> meeting of CCI are regularly pursued with a view to present updated progress/Implementation status of the decisions of CCI in its ensuing meeting for further guidance and directions.

#### 4: TOURISM SECTION

#### 4.1: INFORMATION/OBJECTIVES/ACTIVITIES

After the 18<sup>th</sup> Constitutional Amendment, the subject Tourism was transfer to Ministry of Inter Provincial Coordination, vide Memorandum No. 4-1/218-Min-I dated 11<sup>th</sup> December, 2018. Ministry of Inter Provincial Coordination is making efforts to take lead for revival of tourism industry in Pakistan, to handle matters pertaining to International Organizations and agreements/MoUs relating to tourism. As a mandate to handle matters pertaining to Department of Tourist Services (DTS) in Islamabad is attached with this Ministry.

Tourism is very close to the heart of Honorable Prime Minister of Pakistan. The present government is focusing on tourism and a Task-Force on Tourism under the chairmanship of Prime Minister, with provincial representation, has been constituted to discuss strategic, social, economic, and other key issues related to tourism. Recommendations of the Task Force are to be identified for the next five to six years. The responsibilities of provinces and local governments are much important and wherever the Federal Government is responsible, it will provide the necessary leading role for uplift of tourism in Pakistan. In order to promote tourism in Pakistan a National Tourism Coordination Board (NTCB) has constituted headed by advisor to the Prime Minister. The NTCB has further formed nine (09) Working Groups (WGs) based on following focused area to proceed further in this regard.

- i. Cultural, Heritage and Archeology Tourism Working Group
- ii. ECO Tourism Working Group
- iii. Branding and Marketing Working Group
- iv. Regulatory & policy Reforms Working Group
- v. Religious Tourism Working Group
- vi. Investment Promotion Working Group
- vii. Infrastructure & Facilitation Working Group
- viii. Adventure Tourism Working Group
- ix. Trans Himalayan Jeep rally Working Group

#### 4.2: PERFORMANCE/ACHIEVEMENTS

The detailed performance of PDM wing related to tourism during 2018-19 is as under:

- PDM wing is actively playing its vital role to streamline the tourism related issues ranging from bridging the gap between the three tiers of the government, visa, immigration, security development of tourism related destinations, investments perspectives, thematic tourism, and taxation, etc.
- Corresponded and coordinated with Ministries/Divisions/Provincial Governments on tourism related matters.
- Corresponded with PATA, IOTO, and WTO through M/o Foreign Affairs for development of travel and tourism.
- This section released an amount of Rs.2,800,000/-(PATA) Rs.5,515,000/- (WTO) Rs230,000/0 (IOTO) in respect of annual contribution to the Pacific Asia Travel Association, World Tourism Organization and India Ocean Tourism Organization respectively.
- Dealt with the function of tourism to share knowledge, experience and resources among the different countries in respect of tourism cooperation.
- MoU on cooperation in the field of tourism with Government of Qatar was signed on 22<sup>nd</sup> June, 2019. The Federal Cabinet has accorded approval for entering into negations with republic of Sudan and Democratic Socialist Republic of Srilanka.
- The MoUs with different countries on cooperation in the field of tourism has been initiated and after vetting from all stakeholders

- they are under process for initializing negations/finalization (Annexure-A).
- Coordinated with Law and Justice Division, Ministry of Finance, Ministry of Foreign Affairs, Economic Affairs Division, Punjab, Sindh, KPK, Balochistan, AJK and GB for vetting and views/comments of MoUs. The list of agreements pending for vetting and vies/comments from stakeholders is placed at (Annexure-B).
- PDM wing liaise with Department of Tourist Services (DTS) on matters related to travel agencies, tourist operators and taxation.

This wing has performed the function of Youth Exchange Program to share knowledge, experience and resources between the two countries in respect of youth development. The detailed performance of PDM Wing during 2018-19 is as under:-

- Correspond and liaise with Ministries/Divisions/Provincial Governments on Post Devolution Matters.
- Agenda items along-with working papers regarding the Post Devolution issues were prepared for the meetings of various forums such as Functional Committee on Devolution Process, Senate Standing Committee on IPC, and National Assembly Standing Committee on IPC.
- Necessary information along-with supporting documents specially related to proceedings of implementation Commission are being provided to Parliament Divisions/Departments such as National Assembly Secretariat, Senate Secretariat, Supreme Court High Courts and other Divisions/Departments as per available record of the Wing.
- On the advice of Ministry of Foreign Affairs this Ministry processed MoU with Republic of Korea. The Federal Cabinet had accorded approval for entering into negotiation with Republic of Korea.

- The Cultural Exchange Program is being added as a section of the MoUs being developed by the Ministry of information, Broadcasting and National Heritage with the Republic of Bulgaria, Republic of Portugal, Turkmenistan, People's Democratic Republic of Algeria and Mauritius.
- ➤ MoUs with neighboring countries like Bangladesh, Maldives, Bhutan, Nepal and Iran on cooperation in the field of youth development are under process for initializing negotiations.
- ➤ Cabinet has accorded approval for singing of agreement/MoU on Youth Development with Federal Nigeria and Afghanistan. Ministry of Foreign Affairs has been requested to inform this Ministry about the date and venue for signing of the agreement/MoU.

The Committee had been instrumental in various important decisions of national significance and resolution of contentious issues amicably. The Committee has held 27 meetings since 1993. Preparations for the 28<sup>th</sup> meeting since 1993. Preparations for the next meeting of the IPCC are underway.


#### MAJOR ASSIGNMENT PERFORMED BY THE IPC WING

- II. Efforts were made to coordinate with all provincial Governments for seeking their views/comments "Proposal for free and speedy resolution of citizen complaints against maladministration by Federal and Provincial Governments /Local Agencies under one roof at gross root level."
- III. Coordinated with all Provincial Governments for seeking their views/comments for" Taxes Levied on the Transfer of Immovable Properties by Federal Government (Board of Revenue, Punjab.)"
- IV. Coordinated with all Provincial Governments for seeking their views/comments for "Devolution of Institutions/ Officers related to the Fisheries.
- V. #### 8. TRAINING & RESEARCH WING

#### 8.1 INTER BOARD COMMITTEE OF CHAIRMEN (IBCC)

IBCC is a body of 47 members organization (29 BISEs, 3 BTEs, 5 TBBs (Text Book Boards), 5 Bureaus/Directorates of Curriculum, Allama Iqbal Open University (AIOU), Karakorum International University (KIU) Agha Khan University Examination Board (AKU-EB) Karachi & Secretary IBCC, Islamabad which serve as a forum of Chief Executives of its members to discuss and resolve issues relating to Policy and Planning, Academic development and administration of Examination, Inter Board/Province migration, Attestation of Certificates, Equivalence of local and foreign certificates.

#### 8.2 ACHIEVEMENTS DURING PERIOD 2018-19.

- 1. Five meetings each of "IBCC Forum" comprising 47 members and Equivalence Committee" comprising 13 members (EC)" have been conducted during the period in order to resolve various issues confronting with examination system, and attestation and equivalence up to class XII.
- 2. Ten subcommittee meetings regarding the matters concerning public importance were convened and decisions of national importance were taken.
- 3. A special resolution of IBCC forum was passed regarding the online verification system from BISEs from all over Pakistan which will reduce the time of verification from Board from 20 to 30 days to just 5min and a click away.
- 4. A Public Grievance Desk/Cell has been established in IBCC and a permanent telephone line, Email, staff members has been designated to address public Inquiry / complaints / grievance.
- 5. Earlier time mechanism has been established in IBCC Secretariat and its sub-offices to take prompt action on issues of public importance.

- 6. A separate public washroom facility for female visitors and female staff members of IBCC has been established at IBCC Secretariat premises.
- 7. The court cases against the department has been reduced by solving the litigations through prompt decision making.
- 8. The equivalence cases of IBCC sub-offices has been sent to others sub-offices for signature to insure transparency.
- 9. It was observed that attestation companies used to exploit the daily visitors at IBCC offices and charged them extra fee in the garb of processing charges. This practice was discontinued and open door policy was introduced in the attestation department of IBCC.
- 10. The draft ACT/ Ordinance of IBCC was revised according to the guidelines of Ministry of IPC and Law and Justice division.
- 11. Data has been collected, analyzed and disseminated on exams and assessment for quality improvement.
- 12. About <u>40200</u> qualification equivalence certificates have been issued.
- 13. About **99461** SSC and HSSC certificates including School Leaving Certificates have been authenticated/attested.

Following decisions National Importance in in Secondary Education have been taken by IBCC Forum during this period:

Equivalence Of Intermediate (Pre-Agriculture) offered by University of Agriculture Faisalabad, Gomal University, D. I. Khan, Agriculture Institutes and Other Universities Of The Country With HSSC (Pre-Engineering & Pre-Medical) Of Boards (BISEs) till 2019 with the condition of not offering any HSSC Study Programme in future without permission of IBCC.

Introduction of Certificates and DMCs of all BISEs in Pakistan having Security Features. It was resolved that uniform security features should be identified after taking all the patterns from all BISEs which will become mandatory to be adopted by all BISEs in Pakistan. The forum further

resolved that the results data will be shared through read-only access with IBCC Secretariat via online verification mechanism.

Timely Verification of Equivalence Certificates of IBCC by Universities and Professional Colleges.

Training of Chairmen/CEOs and other Officers of Boards and IBCC by LUMS, IBA and other International Organizations

The rapidly changing education landscape and emerging trends in examinations and evaluation support the notion that the existing secondary and higher secondary examination system needs Improvement in any country. However, such improvement should lead to transformation that ensures assessing students' academic abilities, their academic growth, and creating a healthy academic competition based on education standards. Maximum limit of fee of such training should be Rs. 60,000/- for Pakistani Universities and Rs. 100,000/- for International Universities/organizations in addition to travelling expenditures.

Draft of IBCC Employees (Service) Regulations and regularization of services of daily wagers of IBCC in light of judgment of honourable Islamabad High Court, Islamabad ICA No. 340/2017 were submitted before the IBCC Forum for consideration and approval.

IBCC Forum upheld its decisions taken in 49<sup>th</sup>& subsequent meetings and agreed to approve the IBCC employees (Service) Regulations and regularize the services of daily wagers as well.

Equivalence of "2 years Diploma in Culinary Arts" offered by the Punjab Board of Technical Education has been approved for equivalence with HSSC (Humanities Group). Entry level qualification of said course is Matriculation. Duration of the course is two year and possesses all compulsory subjects of Urdu, English & Islamiat/Civics for Non-Muslims in the Scheme of studies of 1<sup>st</sup> year and Urdu, English & Pakistan Studies in the Scheme of Studies of 2<sup>nd</sup> Year according to requirements of IBCC. IBCC Forum recognized Diploma in Culinary Arts offered by Punjab Board Technical Education, Lahore as equivalent to HSSC (Humanities) of Pakistan.

Admission of students having HSSC (Pre-Medical & Pre-Engg/ICS) into Third Year of DAE to enhance their practical skills to pursue career and to meet the need of local industry. The students having HSSC Pre-Engineering, Pre-Medical & Computer Science will be granted waiver of subjects already passed at HSSC level. However, they may study two years further in the DAE programmes to cover all aspects of the relevant technical syllabus. The students having HSSC Pre-Medical may also require to pass the complete subject of Mathematics of DAE level in addition to other required subjects.

IBCC It has decided for the examining bodies having internal system of evaluation but this evaluation is endorsed by Ministry of Education of that country by issuing their final transcripts and diplomas/certificates by Ministry of Education or equivalent department then the deduction percentage would be 10% in such cases. Apart from above, Internal Evaluation will have 15% deduction and the rate of deduction upon externally evaluated certificates will remain 7.5% as already resolved by IBCC on certificates achieved after 31<sup>st</sup> May, 2010.

National Summer Camp for talented Boys was held from 22-27 July at Islamabad. About 100 students (Position holders) from all Pakistani Boards participated in the Summer Camp. The participants were taken to Parliament House and President House they had an opportunity to meet the Speaker National Assembly and honorable President of Pakistan.

After assurance of Controller of Examination, AIOU, Islamabad that in future no study programme at SSC and HSSC level apart from National Scheme of Studies will be started without getting NOC from IBCC. Furthermore, HSSC (Family & Community Health Group) has already stopped in 2007 by AIOU. Therefore, in view the of above, the certificates already issued by AIOU in HSSC (Family & Community Health Group) will be attested by IBCC Secretariat and its Regional offices as one time relief.

In view of sufferings of the short certificates holders and migration certificates of Pakistani General Education and Technical Boards, IBCC

resolved to approve the attestation of short courses certificate and migration certificates issued by member Boards of IBCC.

A practice has been has been started by IBCC that hosts/member Boards may brief the IBCC Forum about best practices adopted/introduced by them for betterment of Examinations system. This practice has been very useful for other members to adopt ideas and practice of other Boards for betterment of their own system of examination.

IBCC approved Equivalence of two years Course in Para-Medical Sciences (Medical Technologies) offered by Medical Faculties of all provinces of Pakistan equivalent to HSSC (Medical Technology Group)

Earlier graduates of these medical faculties having obtained approved courses of i) Medical Laboratory Technology, ii) Medical Imaging Technology, iii) Operation Theatre Technology, iv) Ophthalmic Technology, v) Physiotherapy Technology, vi) Dental Hygiene may be granted equivalence on passing compulsory subjects of English, Urdu, Islamiat & Pak Studies of HSSC level from Examination Boards and Medical Faculties may get affiliation with concerned Board of their territorial jurisdiction for examination of these approved technologies from 2019 onwards. However, a letter may also be issued to provincial controlling authorities of Medical Faculties to direct them NOT to hold examinations of 2020 for these technologies at their own.

Hundreds of passed out students of Medical Faculties will benefit from this decision.

IBCC Forum agreed to develop National Question Item Bank at national level in which items will be stored according to the difficulty index and resolved to start working on it immediately. It was further resolved that the item Bank should be made on the basis of scheme of studies and not syllabus so that to the questions items in it can be adopted across the board.

#### 8.3: PROGRESS TOWARDS A UNIFORM ACADEMIC CALENDAR

By this decision all Pakistani Boards will announce SSC result before 15 July and HSSC Results before 15 August every year. This will help to start academic session in universities on  $1^{st}$  October.

IMPROVEMENT IN THE WORKING OF ATTESTATION OF CERTIFICATES, DIPLOMAS AND RESULT CARDS OF PAKISTANI BISES AND BTES IN VIEW OF C.M.A. NO. 8727 OF 2018 IN CIVIL PETITION NO. 2403 OF 2017 IN THE HONOURABLE SUPREME COURT OF PAKISTAN

The IBCC Forum has approved the following necessary action to further improve the procedure of attestation and curb the malpractices.

- A. Complaint be lodged with FIA for lodging of FIR against the holders of fake certificates / DMCs / Diplomas.
- B. A fine of Rs.10,000/- as punishment be realized from offender.
- C. Ban on attestation of Certificate / DMCs/Diploma for the period of two years shall be imposed on offender in case of reproduction of fake certificate / DMCs/Diploma to IBCC.
- D. Case of holders of fake certificates be referred to its issuing authority for strict disciplinary proceedings including quashing of educational record as per procedure / Board Rules.
- E. Higher Education Commission and Ministry of Foreign Affairs be requested to communicate information regarding fake certificates to local universities and Foreign Missions, respectively.

Following decisions on new Educational Qualifications have been taken by Equivalence Committee during this period:

Equivalence of Foundation Diploma UK after having GCE 'o' level in required number of subjects and GCE advanced subsidiary level in three subjects from CIE, UK with HSSC (pre-engineering) of Pakistan

Policy decision regarding subjects passed at international advanced level from Edexcel International with grade a to e and "#" postfix with grade

HSSC (pre-engineering), after passing "further mathematics" instead of "mathematics / pure mathematics from Edexcel international, UK (UAE)

#### 9: NATIONAL INTERNSHIP PROGRAM (NIP)

No government in the world can ensure 100% employment but can provide enabling environment where the youth can develop themselves to create positive economic activity. Keeping in view the varied outcomes of work-based learning, such experiential learning opportunities for young graduates, is currently one of the most influential ideas in public higher education and workforce development policy across the world.

University education is at the top of education pyramid and graduates so qualifying need to be employed in a productive manner. Fresh graduates have knowledge of only an academic nature and lack the experience organizations need for intake. This mismatch leaves a large pool of unemployed but highly educated youth, resulting in a dangerous youth bulge. Internships bridge this important gap by not only providing the needed skills and practical training to the youth who can be gainfully employed, but also provides them income until they find a regular job. An internship is a part-time job for specific period, paid modestly, in which the interns gain knowledge while contributing to the organization in a win-win situation with ultimate benefit to the economy.

For students, an internship provides an understanding of a real work/business situation. It consists of an exchange of services for experience between the intern and the organization. From the organization's perspective, internships are used to determine if the intern has an interest and ability in that field after the real-life experience. An internship can also help an intern to create a professional network that can assist with letters of recommendation leading to future employment opportunities.

Internship programs are popular worldwide and countries have continuous internship programs, due to the following benefits:-

- o Practical, hands-on experience for the graduates
- o Enhanced resume or CV to enhance prospects of future employability
- Networking opportunities for the interns to seek job
- o Internships are highly likely to lead to employment opportunities in the respective organizations where they undergo internship
- The benefit of bringing an intern into full-time employment is that he
  is already familiar with the organization, its position, and as intern
  usually needs little to no training.
- o Internship provides a college graduate ability to participate in a field of his/her choice to receive hands-on learning about a particular future career, preparing his/her for full-time work following graduation.

Pakistan's National Internship Program (NIP) was designed during the FY 2006-2007 by the then government, under the Establishment Division. The Program was transferred to Ministry of Youth Affairs in January 2009 but

was transferred back to Establishment Division after devolution of Youth Affairs in December, 2010. The provincial component of NIP was discontinued w.e.f. 01-07-2011 and the federal component was transferred from Establishment Division to Ministry of Education, Trainings and Standards in Higher Education vide Cabinet Division's Notification dated 28-7-2011. In pursuance of Cabinet Division's memorandum dated 30<sup>th</sup> September, 2014, the National Internship Program (NIP) under the Ministry of Federal Education and Professional Training has been transferred to Ministry of Inter Provincial Coordination (IPC). The provinces have been taken on board in management of the program for its widespread acceptability and effective implementation as the scheme is meant for whole of Pakistan (all provinces and the erstwhile FATA, GB, AJK and ICT areas).

#### 9.1: NIP ACHIEVEMENTS (NON-DEVELOPMENT PROGRAMS)

During the initial five years (2006-07 to 2012-13), NIP office offered internships to 99,306 unemployed youth across Pakistan in public sector organizations only, costing **Rs.12.0 billion** (approx.) financed out of the regular budget. Details of phase wise placements of interns are as under:-

#### II. Prime Minister's Youth Training Scheme (PMYTS) 2015-18

(with NIP as implementation agency of PMYTS)

The NIP office under the Ministry of IPC formulated PC-I of the Prime Minister's Youth Training Scheme (PMYTS) which was approved by ECNEC on 04-09-2015 at a cost of **Rs.23,594.911/- million** for three years 2015-18. The stipend amount was enhanced from **Rs.12,000/-** to **Rs.15,000/-** per month w.e.f July 01, 2017 with the approval of CDWP/ECNEC. Accordingly, the total project cost enhanced to **Rs. 26,690.911/- million** from **Rs. 23,594.911/- million.** Further, the age limit for candidates from Balochistan, GB, FATA, AJK and southern Punjab was increased to 30 years. For the rest of Pakistan age limit as 25 years.

#### **III. Main Features of the PMYTS**

- One-year paid internship to unemployed educated youth (degree/diploma holders), as a solution to their joblessness due to inexperience
- Interns are placed with various public & private sector organizations all over Pakistan having functional similarity with their academic qualifications and area of specialization
- The interns are at liberty to leave the program at any stage on 15 days advance notice
- The interns are entitled to a monthly stipend of Rs. 15,000/- during the course of internship
- The interns are issued experience certificates after successful completion of their internship graded on a formal performance rating mechanism.

Allocation of interns was made in accordance with the provincial/regional quotas. The selection is made as per their domicile but can be placed in any organizations outside their domicile/region based on demand profile and matching of applicant profile. Annual allocation of interns in accordance with the provincial/regional quotas is as under:

# IV. PMYTS ACHIEVEMENTS DURING THE FINANCIAL YEARS 2015-16, 2016-17 & 2017-2018

As per approved PC-I, 50,000 interns were required to be engaged in Phase-I but the targeted number could not be achieved due to less joining by the selected interns and the same phase spread over 4 batches. The last batch was placed in June, 2017. Thus, placement in Phase-I of the scheme took two years to be completed. Phase-II of the scheme started in March 2017 and placement of interns was materialized on 1-7-2017. About 45,000 interns were selected from all over Pakistan instead of 50,000, due to deficiency of applicants from Sindh, out of which only 35,000 interns joined, leaving a balance of 15,000 in Phase-II.

So far, 81,047 interns (Male 58995 & Female 22052) have completed their one year internship upto 30-06-2018. Details are as under:-

#### V. PMYTS ACHIEVEMENTS DURING THE FINANCIAL YEAR 2018-2019

During the financial year 2018-2019, funds to the tune of Rs.971.444 million has been released to clear the outstanding liabilities of interns on account of stipend out of which an amount of Rs.866.201 million have been paid to approximately 29,000 interns having active bank accounts. The Prime Minister's Office vide letter dated 1<sup>st</sup> January, 2019 addressed to the Ministry of Finance, directed for release of funds for payment of outstanding liabilities on account of stipend to the interns of PM's Youth Training Scheme.

It is submitted that PC-I of the Prime Minister's Youth Training Scheme was approved by the ECNEC for a period of three years (01.11.2015 to 30.10.2018) and funded under block allocation for Prime Minister's Youth Initiative. The last batch of 33,458 interns was engaged for one year training by the Ministry of Inter Provincial Coordination vide No. 2(1)/2017-NIP dated 20<sup>th</sup> June, 2017. The interns had been paid out of quarterly releases of funds. However, payment of stipend for the months of April-June 2018 could not be made on account of non-release of funds for the fourth quarter of FY 2017-18.

In response to directive of the P.M Office, Finance Division has agreed to release the funds amounting to Rs. 971.444 million as Technical Supplementary Grant (TSG) for clearance of the above said liabilities. This was a great achievement of the present government to clear the outstanding liabilities of interns on account of stipend for the months of April-June 2018, amounting Rs.866.201 million to approximately 29,000 interns. The present

Government has emphasized the urgency of payment on account of hue & cry of the interns and increasing number of legal notices from judicial forums regarding payment of dues.

PC-I of the scheme has been extended up to 30-06-2019 for the purpose with the approval of Secretary, IPC as per the guidelines of Planning, Development & Reforms Division.

During M/o IPC presentation to the Prime Minister on 11-09-2018, "the Chair was pleased to express the need for revamping the PSDP portfolio and appreciated the need for continuity & expansion in scope of the ongoing Youth Development Programs, National Internship (NIP). It was also advised to involve SECP in placement of interns in corporate sectors".

On a summary submitted by the M/o IPC, the Prime Minister has been pleased to approve the proposal of "National Youth Development Framework" contained at para-4. Thematic areas of the framework (internship as one of the intervention area) are as under:-

- i. Mainstreaming marginalized Youth
- ii. Employment and Economic Empowerment
- iii. Civic Engagement
- iv. Social Protection
- v. Health & Wellbeing
- vi. Youth focused Institutional Reforms

As per the said framework, a National Youth Development Program has been launched to implement the framework's vision and mission at national, provincial and grass roots levels.

It is worthy to mention that PMYTS is in line with the vision of the present government for enhancing the skills and capacity of the educated youth to cater for the ever-increasing unemployment in the country. The need was also highlighted by the Prime Minister in his maiden address to the nation. The scheme is quite vital in its design, execution and result oriented which has successfully provided not only on the job training but perspective employees in various sectors of the public &private organizations. It also provides the much-needed financial cushion to the unemployed youth while at the same time improving their skills set for the future employment thus making them useful for economic integration plan.

The expenditure incurred so far is Rs. 11,289.920/- million. Detail of funds received from Finance Division and expenditure incurred during the Financial Years mentioned below:

#### 11: FEDERAL LAND COMMISSION

#### **Brief of organization**

The Federal Land Commission is statutory body of the Federal Government of Pakistan created on 3<sup>rd</sup> January, 1973 through an Act of the parliament by inserting Para 4-A in the Land Reforms Regulation, 1972 (MLR-115) and then reconstituted under land reforms Act, 1977. FLC is a judicial forum provided with the revisionary jurisdiction to hear and decide the matters pertaining to Land Reforms of any nature. This judicial forum consists of Registry and Legal Sections to assist and manage the Court work. Provincial Inspection Team located at four provinces also assist the Courts.

#### **Objective/Activities.**

2The objectives of the Land Reforms were to effectively breakup the iniquitous concentration of landed wealth in a few hands, reduce income disparities, increase agriculture production, reduce un-employment, streamline the administration of land revenue and agriculture taxation, and ensure an effective and progressive relationship between land owners and tenants. Land reforms were also intended to rectify the defects and drawbacks which exist in the agrarian structure on account of absentee landlordism and to cut down the holdings of big landlords.

#### **PERFORMANCE / ACHIEVEMENTS**

As a judicial forum, Federal Land Commission has decided **36** land reforms cases during the stipulated period. According to the data collected by the Federal Land Commission from the Provinces, the position of the land readily available for disposal/allotment as on 30.06.2019 (Annexure-A).

As per policy of the Government, Federal Land Commission, like other organizations, has taken various steps for socio economic uplift of the poor peasants.

The socio-economic change at the grass roots level is the top most Priority of the present government. It will effectively improve living condition of the poor farmers in the country ringing economic revolution in their lives as they

will be physical owners of agriculture land. This will also boost the standard of living and increase food production, as well as reduce the import bill of food items.

#### 13: PAKISTAN SPORTS BOARD

The Pakistan Sports Board was established as a body corporate under the provisions of sports (Development and Control) Ordinance, 1962 for the purpose of promoting and developing uniform standards of competitions in sports in Pakistan comparable to the standards prevailing internationally and regulating and controlling sports in Pakistan.

Pakistan Sports Board under the Ministry of Inter Provincial Coordination is the supreme authority to control and promote sports in the country and also act as executing agency to implement the government policies.

Pakistan Sports Board has wide range of sporting facilities at its Headquarters and coaching centers at Provincial Headquarters. These facilities are primarily used for national training camps and holding of various national and international competitions. In addition, these facilities are also allowed to general public on normal membership basis.

The Government is determined to promote sports culture in Pakistan and provide all possible financial and administrative support to the affiliated sports organizations in Pakistan.

#### 13.1: NATIONAL TRAININGS CAMPS

Pakistan Sports Board organized the different National Trainings Camps in order to train National players/teams for participation in the international sports competitions during the period from July, 2018 to June, 2019. The detail is attached at **Annex-I**.

#### **Kashmir Solidarity Day**

Pakistan Sports Board organized Hockey and Football matches to mark the Kashmir Solidarity Day, on 5<sup>th</sup> February 2019 at Pakistan Sports Complex Islamabad.

#### Hockey, Football, Kabaddi and Cricket matches Independence Day

Pakistan Sports Board organized Hockey, Football, Kabaddi and Cricket matches on  $13^{th}$  and  $14^{th}$  August, 2018 at Pakistan Sports Complex, Islamabad to mark the Independence Day.

#### **Tree Plantation Campaign**

Keeping in view the instructions issued by the Prime Minister of Pakistan, Pakistan Sports Board launched the Tree Plantation Campaign 2018 at Pakistan Sports Complex, Islamabad on 3<sup>rd</sup> September, 2018. Dr. Fehmida Mirza, Federal Minister for IPC as Chief Guest planted a sapling. Talking on the occasion, she said that this tree plantation campaign is the part of the Prime Minister's Tree Plantation drive. She also requested electronic media to play its role for the promotion of sports in the country by airing at least one-hour sports programs on daily basis.

### **Meeting with President, Pakistan Baseball Federation**

A three-member delegation of Pakistan Baseball (PFB) headed by its President, Syed Fakhar Shah called on the Federal Minister for IPC, Dr. Fehmida Mirza in her chamber at Parliament House on Thursday, 7<sup>th</sup> March, 2019. Syed Fakhar Imam briefed the Federal Minister regarding the efforts being made for the overall development of the game in the country.

#### 13.2: MAJOR INTERNATIONAL EVENTS 2018-19

Pakistan Sports contingents participated in the following major international events during the financial year 2018-19.

#### 17<sup>th</sup> Asian Games

245-members Pakistan Sports Contingent participated in the 17<sup>th</sup> Asian Games scheduled in Indonesia from 18<sup>th</sup> August to 2<sup>nd</sup> September, 2018. Pakistan contingent did not performed well and could only get 04 bronze medals in Athletics, Karate, Kabaddi and Squash events.

#### **Asian Para Games**

Pakistan won 1-Bronze medal in Wrestling and Asian Para Games held at Jakarta, Indonesia from 06-13 October, 2018. Pakistan won 2-Gold and 01-Bronze medals in Athletics.

#### **3<sup>rd</sup> Summer Youth Olympic Games**

07-member Pakistan Contingent participated in the 3<sup>rd</sup> Summer Youth Olympic Games held at Buenos Aires, Argentina from 06-18 October 2018. Pakistani Wrestler Mr. Inayat Ullah could only win 01 bronze medal in Freestyle 65 Kg category.

#### **Other International Achievements**

Pakistan Athletics Team consisted of 12 Athletes participated in 18<sup>th</sup> Asian Olympic Games at Jakarta (Indonesia) from 18<sup>th</sup> August to 02 September, 2018. Pakistan team won one Bronze medal in Javelin throw.

Pakistan Badminton team participated in the Dubai Junior International Series Badminton Tournament played in Dubai from 26-30 September, 2018 in which Raza Ali Adil reached in the semi final of U-19 and won Bronze medal.

Pakistan Baseball team participated in BFA U-12 Asian Baseball Championship- 2018 held in China from 13<sup>th</sup> to 19<sup>th</sup> August, 2018 in which total 08 teams participated from different countries. Overall performance of Pakistan U-12 Team was good. Pakistan got 4<sup>th</sup> position in the event.

Pakistan Baseball team participated in 18<sup>th</sup> Asian Games, 2018 held in Jakarta (Indonesia) from 18<sup>th</sup> August to 2<sup>nd</sup> September, 2018 in which total 10 Teams participated from different countries. Overall performance of Pakistan team was good. Pakistan got 5<sup>th</sup> position in the games.

Pakistan Hockey team participated in 5<sup>th</sup> Asian Champions Trophy held at Oman from 18<sup>th</sup> to 28<sup>th</sup> October, 2018 in which 6 teams of India, Japan, Korea, Malaysia, Oman and Pakistan participated. Pakistan got 1<sup>st</sup> position while India and Malaysia got 2<sup>nd</sup> and 3<sup>rd</sup> positions respectively.

25<sup>th</sup> Asian Individual Squash Championship was held at Chennai (India) from 26-29 September, 2018. Pakistan Squash Federation sent a group of 07 players for participation in U-13,U-15,U-17 & U-19 age categories. Syed Anas Ali Shah won Silver Medal in U-13, M. Hamza Khan won Gold Medal in U-15, Haris Qasim won Gold Medal in U-17 and Abbas Zeb won Gold Medal in U-19 categories while Ashab Irfan and Uzair Shaukat lost in quarter finals of U-15 & U-17 age.

Pakistan Junior Squash team comprising of Abbas Zeb, Farhan Hashmi, Haris, Qasim and Hamza Khan participated in Asian Junior Team Squash Championship held at Pattaya (Thailand) from 16-20 January, 2019. Pakistan team given an excellent performance and won Gold Medal in the prestigious Championship after 6 years.

The Doha Junior Squash Tournament was played on 15-18 March, 2019. Total 09 Pakistani players participated in various age groups. Hussain Ahmed played 1<sup>st</sup> round (U-11), Shkhiullah Tareen won the final whereas Abdullah Nawaz played semi finals of U-13. In the U-15 category Hamza Khan won the final. Huzaifa Zahid & M Ammad played semi finals whereas Humam Ahmed played quarter finals. However, in the U-17 category Noor Zaman won the event while Asad Ullah stood runner up.

The Qatar Junior squash Tournament was played between 19-21 March, 2019. A group of 9 Pakistani players participated in various age groups. Hussain Ahmed played 1<sup>st</sup> round U-11, Abdullah Nawaz won the final from Sakhiullah Tareen in U-13. Hamza Khan won final of U-15 from Huzaifa Zahid whereas M Ammad played semi finals and Humam Ahmed lost in 1<sup>st</sup> round. In U-17 category Noor Zaman won the event while Asad Ullah played quarter finals.

Pakistan Taekwondo team participated in the 7<sup>th</sup> Fujairah Open Taekwondo Championship, 2019 held in Fujairah (UAE) from 1<sup>st</sup> to 3<sup>rd</sup> February, 2019 in which 40 teams participated from different countries. Pakistan team won 2 Gold 1 Silver and 2 Bronze medals. Pakistani athletes Sinan Ashfaq and Muhammad Danish won Gold Medals; Taimur Saeed won Silver Medal while 8 year old Ayesha Ayaz and Arif Ullah won Bronze Medals during the championship.

Pakistan Taekwondo team participated in the 6<sup>th</sup> Turkish Open International Taekwondo Championship, 2019 held in Turkey from 13<sup>th</sup> to 17<sup>th</sup> February, 2019 in which approx 80 teams participated from different countries. Pakistani athlete Mr. Hussain Anjum lost in quarter final from Uzbekistani athlete by 08 points, Mr. Awais also lost in quarter finals against Turkish athlete by 12 points. However, Mr. Arif Ullah Khan displayed good performance and won his initial three fights and lost in semi final against Russian athlete and won Bronze Medal.
