No manual bids/hard copies shall be accepted, except Pay order & Stamp paper.
Date, Time & Place of publicly opening of Bids.	On 30.09.2025 at 12:00 P.M , Committee Room of Ministry of IPC, 2 nd Floor, New Secretariat, Kohsar Block, Islamabad in the presence of bidders or their representatives of firms/vendors.

3. Interested eligible bidders are requested to register themselves on the EPADS (<https://eprocure.gov.pk>) and submit their documents on EPADS. The interested eligible bidders may obtain bidding documents from the websites of Ministry of IPC, and EPADS.

Earnest money in the shape of Pay Order / Demand Draft/Call Deposit in favour of SO (General), M/o IPC will be submitted to SO (General), Ministry of IPC while bid documents alongwith Pay Order / Demand Draft/Call Deposit should be uploaded through EPADS (scanned copy) on/or before 11:00 A.M by 30.09.2025 (<https://eprocure.gov.pk>). Bids will be opened on the same date at 12:00 P.M.
